Investment Highlights

- Attractive risk-adjusted returns for infrastructure: SARA is a 10-year close-ended fund with a 15%+ equity return target over the fund life
- Once-in-a-generation capital formation event: The Australian Energy Market Operator's (AEMO) forecast implies Australia's energy transition will require >A\$100bn of capex on new-build sustainable infrastructure by 2030⁽¹⁾
- Scalable and diversified platform: SARA mitigates risk via diversification in technology, geography and contracting. SARA invests in both development and operating assets.
- 'Platforms and Portfolios' approach: SARA's investment approach involves seeking a calibrated equity interest in project development companies for the purpose of gaining privileged access and optionality over a pipeline of quality projects
- **Proprietary opportunities:** Strong proprietary sustainable infrastructure pipeline of +20GW, representing equity deployment opportunity of US\$15bn, US\$2bn executable within 12 months
- Partner with experienced investors: Federation's core investment team are ex-senior members of Macquarie's Principal Investment team who have a track record of 23.3% IRR on A\$2.9bn realized value of infrastructure investment
